MW reported new buffers to Mag Bells are finally fitted, but there are several snagging items that Mark has drawn to the attention of Richard Booker and Jonathan Headlam on 5 August

- There is a broken joint cover on the Mag Bells unit
 There is a broken joint cover on the left side above the sit-ups board on the
 Combi Unit
- There is a broken joint cover on the right hand side

 The non-slip surface on the sit-ups board is beginning to peel off in the top
 left corner this is very disappointing as the equipment is not yet 12 months
 old and I would expect this to be covered by warranty.
- The bottom left star screw fixing the sit-ups board to the frame is loose and cross-threaded I raised this during my original snag list and it has not been resolved.

The joint covers seem to be breaking quite a lot (a number have been replaced before) so I hope that Kompan have supplied a box of spares? MW thinsk this issue should be highlighted to Kompan as an area that needs better design as they don't seem fit for purpose.

Mark has requested an action plan for the above snags with a view to agreeing a payment strategy.

Benches

There is a long waiting list for memorial benches. No further action for now, waiting to see what happens.

Boules Court

Commence weeding during Task Day.

With regards replacing the wooden side surrounds the estimated cost of £6,000 cannot be justified. It has been decided to replace just the deteriorated parts. MT suggested contacting New Mills Petanque group (U3A?) for assistance/input.

4 Community Hub Transition Arrangements:

Jubilee Bed

We will move any plants we want to retain We will arrange for the sculpture to be dismantled and stored (MA spoken to blacksmith Wayne Chaisty) along with the information display panel. MW will also ask Wayne about a re-configuration of the sculpture.

Frog and reading circle

We need to decide what plants we want to retain and place elsewhere for now. The Frog will be very near to the Heat Source Pump and would be best to be moved elsewhere in the park potentially on a new concrete plinth. It was suggested that Rose Frog could be relocated to the triangle of land near the Band Room ,facing the playground and recreating the Reading Circle there.

Toilet Block flower beds

The discussion about saving/retaining plants became more general, covering more flowerbeds. Joyce circulated some photographs she had taken of plants she considered worth saving and there was discussion about the best time to start digging up and where and how to re-plant things temporarily. Climbing plants need support during the transition. DJ offered to lend some large pots to replant climbers etc. and will liaise with Mick early next week.

The one by the bowling hut will be removed at the same time as the Sculpture display panel and Beaver/Rotary sign. Possible storage location for these and the sculpture could be in the WW1 Pavilion/Garden Store (Bowling Hut) if there is space.

Plaques in Toddler Play Area

One plaque included detail of when pond was created and then another of when the pond was infilled. It was suggested that a third plaque is created to confirm the build of the new Community Hub over the location of the pond and then all plaques relocated adjacent to the relocated footpath. The existing plaques will need to be removed and placed into storage, ahead of the Enabling Works commencing.
